"Council notes with grave concern the breach of confidentiality relating to item 6.56 at the August meeting of Antrim and Newtownabbey Borough Council and refers any breach of confidentiality found by the Council's investigation to the Northern Ireland Local Government Commissioner for Standards as a complaint."
